Singles welcome. We will match up and notify partners by Thursday, February 13th

Cost: **\$25 per paddle, \$50 per team**

Where: Bronxville, New York: village & neighboring courts (directions on reverse)

Details: Three matches for all entrants with Consolation and two Reprieve rounds (weather permitting). Prizes for all Winners and the Main Draw finalists.

Food: Morning coffee, tea, donuts, bagels; lunch at the Bronxville Village paddle hut; late Saturday afternoon: wine, beer and heavy hors d'oeuvres. Guests welcome; \$5 for lunch, \$5 for later (try to advise us ahead of time). If they get bored, Bronxville has great shopping in walking distance!

We will notify one member of each team its starting time by phone Thursday evening, February 13th. The first rounds start at 8:30 and 9:30 am at the Bronxville Village and neighboring courts. We try to schedule those from farthest away for the 9:30 start. Please arrive at the courts 20 minutes before your starting time to get your court assignment and directions to neighboring courts, if needed. Call us if you want us to try to find local private housing for Saturday night.
